
To obtain this service, your company must have assessed through the CSA.

How does it work?

An ESG Materiality Assessment is required to prepare the Benchmarking Report on Materiality. The material issues identified in the ESG Materiality Assessment are then mapped to industry- specific CSA criteria and frameworks to show how companies should address the identified material topics in terms of transparency, policies and performance indicators and provide performance benchmarking to the CSA Practice and industry peers.
