
S&P Carbon Control Index Series

Seeking to Minimize Carbon Intensity with Controlled Exposures

The S&P Carbon Control Index Series is designed to measure the performance of eligible securities from an underlying global benchmark index while minimizing the index weighted average carbon intensity, subject to constraints that limit active share.

The optimized weighting process, powered by S&P Global Trucost GHG Emissions data, is designed to significantly reduce the index weighted average carbon intensity while seeking to maintain a low tracking error to the benchmark index and retain the diversification benefits of that benchmark.

The indices also exclude companies with business activities widely deemed to be unacceptable in an ESG benchmark index, including fossil fuels, tobacco, controversial weapons, alcohol, gambling, and adult entertainment.
