# Introduction

## Index Representation

**S&P DJI Decrement Indices.** The decrement indices measure the performance of a strategy tracking a given S&P DJI index from which a pre-determined quantity of index value is deducted periodically. The value deducted may be expressed as a percentage of index level or as a pre-determined quantity of index points.

**S&P DJI Increment Indices.** The increment indices measure the performance of a strategy tracking a given S&P DJI index from which a pre-determined quantity of index value is increased periodically. The value increased may be expressed as a percentage of index level or as a pre-determined quantity of index points.

## Index Behavior

**S&P DJI Decrement Indices.** Because decrement indices deduct index value, they systematically underperform their parent indices. Therefore, decrement indices are not intended to be used as the basis of index funds or other financial products that aim solely to replicate the performance of an index. Decrements that deduct index points have different characteristics than decrements that deduct a fixed percentage of index value. As a percentage of index level, index points decrements are not constant through time. For example, a 50-point index decrement from an index level of 1000 corresponds to 5% of index value, while a 50-point index decrement from an index level of 500 corresponds to 10% of index value.

**S&P DJI Increment Indices.** Because increment indices increase index value, they systematically outperform their parent indices. Therefore, increment indices are not intended to be used as the basis of index funds or other financial products that aim solely to replicate the performance of an index. Increments that increase index points have different characteristics than increments that increase a fixed percentage of index value. As a percentage of index level, index points increments are not constant through time. For example, a 50-point index increment from an index level of 1000 corresponds to 5% of index value, while a 50-point index increment from an index level of 500 corresponds to 10% of index value.

## First Value Date (FVD)

The FVD is the first day for which there is a calculated value, back-tested or live, for a given index. If the FVD is the same as the Launch Date, there is no back-tested history for the index.

**Base Value and Base Value Date**

A hypothetical date in which the index was set at 100, 1000, or some other rounded number for calculation purposes.

**Launch Date**

The first-time data is accessible by the public (e.g., available in a file on EDX). It is also the day of the first live value. For Dow Jones indices launched prior to 7/2/2012, the launch date (i.e., the start of live vs. back-tested data) corresponds to DJI's legacy term "Date of Introduction," which was defined as the date at which an index was moved from development to production servers.

The First Value Date is the first day for which there is a calculated value (either live or back-tested) for a given index. For example, Backward Data Assumption inherently assumes that companies currently not involved in a specific business activity (also known as “product involvement”) were never involved historically and similarly also assumes that companies currently involved in a specific business activity were involved historically too. The Backward Data Assumption allows the hypothetical back-test to be extended over more historical years than would be feasible using only actual data. For more information on “Backward Data Assumption” please refer to the FAQ. The methodology and factsheets of any index that employs backward assumption in the back-tested history will explicitly state so. The methodology will include an Appendix with a table setting forth the specific data points and relevant time period for which backward projected data was used.
