## 16 Peruvian companies are sustainability leaders in S&P/BVL Peru General ESG Index

**S&P Dow Jones Indices (S&P DJI)**, the world's leading index provider, and the **Lima Stock Exchange (BVL)**, announced the results of the annual rebalancing of the S&P/BVL Peru General ESG Index, which measures companies that meet certain sustainability criteria within the S&P/BVL Peru General Index.

Following the annual rebalancing, of the 33 constituents that comprise the S&P/BVL Peru General Index, 16 Peruvian companies, which are listed on the Lima Stock Exchange, are included in the S&P/BVL Peru General ESG index.

The S&P/BVL Peru General ESG Index is the first ESG index in Peru. This means that only the most sustainable companies are selected to be a part of the index based on S&P DJI's rules-based methodologies.

The Lima Stock Exchange, which is a subsidiary of *nuam exchange*, recognizes the ongoing efforts of these companies that comprise the S&P/BVL Peru General ESG Index to adopt and maintain more sustainable business practices over time and to be leaders in the Peruvian market.

The S&P/BVL Peru General ESG Index is rebalanced annually in April. The index rebalances for updates to the composition, shares outstanding, investable weight factors, and constituent weights, effective after the market close of the last business day of April. In addition, the index is reweighted after the market close of the last business day of October.
