

EQT AB SET TO JOIN S&P EUROPE 350

- Morrison (WM) Supermarkets (XLON: MRW) will be removed from the S&P Europe 350 and S&P United Kingdom Indices effective prior to the open of trading on **Wednesday, October 27, 2021**, as a result of the company's upcoming acquisition by non-constituent Market Bidco Ltd.
- EQT AB (XSTO: EQT) will be added to the S&P Europe 350 and S&P Euro Plus Indices effective prior to the open of trading on **Wednesday, October 27, 2021**.
