LONDON, FEBRUARY 21, 2023: IHS Markit Benchmark Administration Limited (IMBA) is conducting a consultation with market participants on the cessation of the certain LGIM Matching Plus Indices.

BACKGROUND AND PROPOSAL

Following the termination request from LGIM, IMBA has decided to cease publication of two LGIM Matching Plus indices.
