SUMMARY

- The S&P Europe 350 swiftly recovered the 6% drop it suffered in the first three trading days of August to close the month up 1.6%. Mid and small caps lagged with the S&P Europe MidCap edging 0.8% higher and the S&P Europe Small Cap slipping 0.4%.
- All but one of 16 countries contributed positively to the pan-European equity returns this
 month, with Portugal the only detractor. Switzerland led the way with a contribution of
 0.3% with Germany and the United Kingdom hot on its heels.
- Real Estate was the best-performing S&P Europe 350 sector in August, surging 5.0%. Energy lagged, plunging 2.9%.
- The majority of our reported European factors gained in August. S&P Europe 350 Quality jumped 3.3%, while Risk Control 15% lost its way this month, shedding 1.0%.
- Most of our reported European fixed income indices closed the month in the black, with the iBoxx EUR Liquid High Yield Index the best performer, up 0.9%.
- Having jumped to 31 at the beginning of the month, Vstoxx quickly normalized, and, remarkably, closed 1 point lower than at the end of July, at 15.
