Summary

- Canadian equities finished the month on the upside. The S&P/TSX Composite and S&P/TSX 60 increased 1.2% and 1.7%, respectively.
- Canadian sectors posted mixed performance for the month, with Information Technology leading, up 6.2%, while at tail of the pack, Consumer Staples fell 3.5%.
- Among industries, the S&P/TSX Composite Diversified Banks rose 3.3% for the month, while the S&P/TSX Global Base Metals fell 3.3%.
- Thanks to optimism surrounding a soft landing and encouraging inflation results, U.S. large-cap equities managed to recover from the trouncing of stocks at the start of the month to finish August with a gain. The S&P 500 was up 0.2% in August, outpacing the S&P MidCap 400 and the S&P SmallCap 600.
- Consumer Staples and Real Estate led among U.S. large-cap sectors. Meanwhile, Energy and Consumer Discretionary were the laggards, a potential signal of risk-off sentiment carrying over from the global tumult earlier in the month.


