

Summary

- Canadian equities finished the month on the upside. The S&P/TSX Composite and S&P/TSX 60 increased 5.9% and 6.1%, respectively.
- Canadian sectors posted positive performance for the month, with Real Estate leading, up 10.9%, while at tail of the pack, Information Technology increased 2.5%.
- Among industries, the S&P/TSX Global Gold rose 13.9% for the month, while the S&P/TSX Global Base Metals fell 2.2%.
- Propelled by weakness in Big Tech coupled with expectations of potential Fed rate cuts, the market witnessed a significant rotation towards smaller-cap stocks in July. The S&P MidCap 400 and the S&P SmallCap 600 were up 6.8% and 11.9%, respectively, outperforming the S&P 500 by a significant margin.
- Real Estate and Utilities led among large-cap U.S. sectors, while Information Technology and Communication Services were the laggards.
